This is real, not some peaceful sit around and align chakras around the campfire shit.

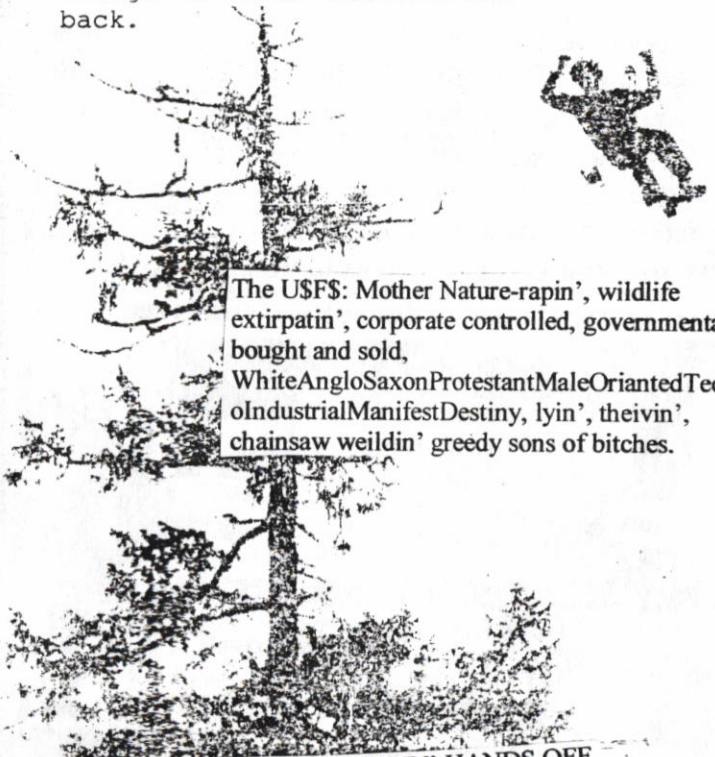
If you want that, please, go to a rainbow gathering and don't bother with wasting anyones time.

Why the Forest Service sucks:

The US Forest Service are the cops of our public lands, brutally cracking down on eco-activists, trying to get thier greedy, bloody chainsaws on our aicient trees, cutting and selling for so many decades that now less then 5% of our natural forests remain.

Even though the forests of Fall Creek are publically owned; even though this area is one of Central Oregons most popular recreation areas (75% don't support commercial logging); even though the entire watershed was set aside as critical habitat to be protected for the Spotted Owl, the USFS continues their attempts at clearcutting 500 acres of huge, ancient trees, including the 96 acre grove we defend.

Attempts to kick us out of our home have included stealing our food, water, clothing and gear, burning our tents and supplies, risking lives of activists by removing them from sketchy platforms, weeks of sleep deprivation, and ridiculous amounts of survalience and harrassment.

Fall Creek Rising!

- We do this because life can't be bought or sold
- because the destruction is irreversable
- because it's great to wipe your ass with damp moss
- because we don't have time to wait for people to wake up
- because we like putting our fists in the face of the law
- because logging roads suck
- because we won't have a second chance
- because the trees can't speak for themselves

What is Fall Creek?

The Fall Creek Clark Timber Sale is 12 units of rare low elevation climax stage douglas fir and hemlock forest, part of the Willamette national forest.

These trees provide homes for flying squirrels, spotted owls, pileated – woodpeckers, red tree voles and an abundance of other wildlife, and a wide array of plant life hanging on for dear life in a fragile and “hostile” environment on the brink of disaster.

The bucket

In 1994 due to the impact of Clinton's Salvage Ryder forestry plan the U.S. forestry service placed Fall Creek into the clear-cut “sacrifice zone” and bid the trees off in 1998 at a timber auction to the Zip-O Lumber Company, who at the time was one of the only companies left in country with a mill designed to cut old growth trees.

The sale in itself is a total of 96 acres. It is literally small patches of old growth in a sea of clearcuts on public land.

In 1992 the Fall Creek area was designated as “critical habitat” for the nearly extinct northern spotted owl.

Getting High with the Fall Creek Treesitters

Two and a half years of action!

the first treesit was discovered in April of 1998 by the forestry service. Perched 198 feet in the air in the upper branches of a tree called “Happy” a small platform and its occupant “Free” (who is now a political prisoner) stood in the way of logging!!

Since that time the Forestry Service has tried innumerable times to break activist spirits, and each time they have failed. Upon the discovery of the first sit the F.S. (Forestry Service) enforced a closure on the surrounding public land the sit was on and tried to thwart any attempt to bring food and water to the treesit.

Of course they failed....

In the next several months activity in the forest picked up to full speed. Now dubbed as “ewoks” the activists expanded the action in the upper forest canopy by building four more sits in the area, all of them connected together by traverse lines which enabled the Ewoks to move from sit to sit, from tree to tree without having to touch the ground!

On the forest floor more activists were getting busy. Ground trolls, as they were dubbed built sketchy lock on platforms blocking the road. Picks and shovels were used to dig up drainage culverts to create roadblocks!

the F.S. continued their raids and sieges on the activists. During a second closure the F.S. brought out spotlights and a sound system and blasted bad country music for four days attempting to starve and sleep deprive the Ewoks.

They send special agents into the woods at all hours to spy and collect intelligence on activist's activities. The spirit of defiance still remains out at Fall Creek and will continue to remain strong till every tree is safe.
